Comment

CPRENorthYorkshire has been made aware of revisions to the submitted application in Marton Cum Grafton by a concerned member of the public rather than by the Council.

CPRENorthYorkshire welcomes the opportunity to comment on the amended application having originally responded to this outline application in June 2018. It is assumed that all previous representations made to the original application remain valid. With that in mind, comments made in this response should be read alongside the CPRE representation of June 2018.

CPRENorthYorkshire acknowledges the additional information submitted by the applicant. However, the objection made on behalf of the charity is not lessened by the provision of this additional information.

It is acknowledged that through the emerging Local Plan for the Harrogate District, the Council chose to allocate this site for development - known as MG7. This sets out that the potential yield for the site is 12 units. Whilst CPRENY acknowledges that the applicant is now proposing 9 units, which is below the suggested capacity for the site, CPRENY are concerned that the current design of this proposal is not in conformity with the site brief set out for MG7 within the emerging Local Plan which concerns the existing pond and eastern portion of the site stating that "approximately 50% of the site, including the pond and a generous buffer, should remain free of new built development".

The Conservation Area Appraisal for Marton cum Grafton sets out that "the view out of the conservation area across the pond from the main road close to the south-east corner of the site and property of Low Garth" - should be enhanced. CPRENorthYorkshire believe that the existing pond contributes towards the setting of the Conservation Area. The pond and open section of this site, which the Council (supported by Historic England - although they objected to site MG7 being included within the emerging Local Plan) advises to be retained has been in situ for over 150years and is a valuable piece of local amenity space for existing residents of the village.

Since the submission of the previous response, the revised National Planning Policy Framework ('NPPF') was published in July 2018. This supersedes the 2012 version when determining planning applications. The revised NPPF is therefore a material consideration which should be used to aid the determination of this planning application.

Conclusion

CPRENorthYorkshire welcomes the opportunity to comment on this revised application, however, do not remove their objection to the proposals for the reasons set out above and in their previous response.
